6.	<b>Description of content:</b> The notified text sets forth phytosanitary measures and procedures aimed at reducing the risk of the introduction or spread of quarantine pests associated with non-manufactured wood packaging material used in international trade which can pose a threat to any country. The text specifies who must comply with the measures and procedures and who is responsible for enforcing compliance.
